- G. Voted on Engineer Ron Stuckel preparing bid specs and packet for upcoming sewer/manhole lining. (The estimated cost for sewer lining \$40 per ft. with laterals from \$250 to \$400 ft.) Lining approx.. 1800 ft. plus 200 ft. of laterals. Trustee John Vosler made a motion to approve. Trustee Julie Miller seconded the motion. Roll call vote. All in favor.
