## TREASURER'S REPORT

Supervisor Barnes read the beginning and ending balances of each fund for the month of October. Trustee Miller made a motion to accept the Treasurer's Report as read. Trustee Isenhart seconded the motion. Roll call vote. All in favor.

## ROAD COMMISSIONER'S REPORT

Road Commissioner Hursey said the road crew has been out in full force sweeping leaves. Sundew Ct. was re-surfaced and various places around township will be patched. He also informed us that he got a grant from the Intergovernmental Grants Dept. for \$70,000 towards the $\$ 180,000$ project on $11^{\text {th }}$ Street. It is in the first stage and will be stretched out over 4 years.

## SUPERVISOR’S REPORT

We had an emergency call on Black Friday on Loop Creek Ct.at our Lift Station. One of our workers was able to fix the pump. It was caused by mine subsidence. Supervisor Barnes also stated that the trees were planted at Loop Creek Park and someone had stripped the branches off of two of them. He talked to Crane Nursery and said they should live.

## PARK BOARD REPORT

Trustee Wallace mentioned that Dave Wallen passed away and that his family wants to donate a bench. He also said the park board is looking at 2018 and started putting plans together on what they want to do. He gave an update on Loop Creek and that trees still need to be planted in Centennial Park.
