A. Trustee Wallace made a motion to accept the October 23, 2018, Regular Board Meeting Minutes as presented. Trustee Miller seconded the motion. Roll call vote. All in favor.

## TREASURER'S REPORT

Trustee Miller made a motion to accept the Treasurer's Report as presented for the month of October, 2018. Trustee Isenhart seconded the motion. Roll call vote. All in favor.

## BUDGET REPORT

Trustee Vosler made a motion to approve the Budget Report as presented for the month of October, 2018. Trustee Miller seconded the motion. Roll call vote. All in favor.

## ROAD COMMISSIONER'S REPORT

Road Commissioner Hursey was absent. His report can be viewed on the website.

#### SUPERVISOR'S REPORT

Supervisor Barnes stated that the 7 manholes that were lined are completed. He also said that Dean Wallen's family donated \$850 for benches in Centennial Park. Also, that we have raised the General Assistance Fund from \$245 to \$304 per the new law that took effect in October. He informed us that we have the ok from St. Clair County for the grant for Loop Creek. That will be combined with the Metro East Park District grant. Mr. Barnes and Ron Stuckel, engineer, will meet with the contractor the week of Dec. 3<sup>rd</sup> to see what work they can start on. Lincolnshire Sewer Project is completed except for a driveway that needs to be concreted and mounds of dirt that need to settle. Mr. Barnes also told us that he was nominated to be on the Township Supervisor's Board of Directors for Southern Illinois.

**PARK BOARD REPORT** Don Wallace said that he is going to present to Mr. Barnes some ideas for next year for Loop Creek. He said that the park board will be looking at maybe getting some swings at Loop Creek next year and would like to include that in our grant process.

**PUBLIC COMMENTS** Vladimir Halupa asked where Dean Wallen has been that was in charge of the parks. Supervisor Barnes informed him that he passed away.

## Road Commissioners report 12/16/2018

The street sweeper and trucks have been continually out daily in full force through the district removing leaves, small road debris and trimming back trees, collecting and or removing dead brush and clearing drains from blockage.

Some small concrete, asphalt road patch work has been added due to the warmer erratic weather conductions making it advantageous complete projects as well as sealing the cracks in the road with tar.

Winter preventive maintenance checks have been conducted and are currently updated as well as insurance and registrations cards on all vehicles.

Winter, Spring, Fall and Summer Supplies have been ordered from IDOT for use with MFT funds for the 2019 season. Seal Coating (Bituminous Products), Culverts, Salt, Patching Materials, Crushed Stone, Chips, Concrete, Sealant.
