Road Commissioners report 02/26/2019

Several winter storms have had the road crew in and on extended various hours preparing, salting and plowing for safety.

January 31. Snow/Ice Event. The crew and I came in at 7 am treating the roads with salt with and the plowing of snow when needed.

February 9. All trucks pre-loaded with salt with and outfitted with plows anticipation of the weather.

February 10. Ice Event. The crew and I came in at 3 am making several passes throughout road district treating the roads with salt

February 15. Snow and freezing rain event. The crew came in at 10 pm to pre-treat.

February 16. Snow/Rain Ice Event. The crew came in at 7 pm treating the roads with salt and plowing when necessary.

February 19. Snow and freezing rain event. The crew came in at 1 pm to pre-treat the roads.

February 22. Bid packages for the B-Street milling and reconstruction project became available on February 22 and will be opened on March 15 at 11 am. This is a rebid project from 10/2018. All bids were rejected then due to concerns to the required specifications and the timing of the seasons rapid temperature changes would cause material availability issues plus concerns with sealing and proper bonding with the project would escalate in price.

Planning and engineering of Phase 2 ON 11TH street with TWM continues with construction expected to begin in the summer/fall of 2019 weather permitting, the relocation of utility's and obtaining of right of ways.

Several calls for trees, limbs and small dead animals in the roadway for cleanup.

The street sweeper and trucks continue to be out weather permitting through the district removing leaves, small road debris and trimming back trees, collecting and or removing dead brush and clearing drains from blockage.
