Road Commissioners report 06/25/2019

Due to the extreme wet weather the B-Street milling and reconstruction project will be starting on or around June 24th. Rooters Asphalt estimates a timeline of construction of 60 working days, weather permitting.

Phase 2 of the 11st project is scheduled to start around July 30. Hanks Excavating is expecting a timeline of the construction phase to be completed within 45 working days, weather permitting.

The outside AC units have been checked for freon levels and leaks. No Issues.

The roof leaks have been repaired.

Crew has been responding to calls for removal of a tree, limbs and dead animals in the roadway and have been out trimming back trees, collecting and or removing dead brush and clearing drains from blockage from the continuing heavy storms. The street sweeper continues to be out removing leaves and small road debris and we are mowing the grass on our right of ways. Small concrete, asphalt road patch work is ongoing.
