## SUPERVISOR'S REPORT

Supervisor Barnes stated that the weather has stopped pretty much everything we have going on in Loop Creek Park, but the picnic table foundations are in, the water fountain pads are in and the BBQ grill pads are in. He said some graffiti had been sprayed on the concrete slab in Centennial Park. The kids had been caught and had to come clean it up.

#### PARK BOARD REPORT

Don Wallace said the members are holding the Clean Up/Construction Day on Saturday, July 20, from 9am to 12pm in Centennial Park. He said he had been out there a week ago and the park looks great. He mentioned they were going to try to build a bench on Saturday and finish cleaning up some logs.

## **PUBLIC COMMENTS**

Greg Warren presented the problem he is having in Greystone Estates. He has had 2 major sewer backups in the 3 years since his house was built. He said one was a problem from construction and the other from a lift station failure. He is asking for a backflow valve system to try and keep the sewage out of his basement. Dane Harrel came to present a non-binding resolution and what other townships in Illinois are doing about gun sanctuary townships.

## Road Commissioners report 07/16/2019

The B-Street milling and reconstruction project started on July 8th. Rooters Asphalt estimates a timeline of construction of 30 working days, weather permitting.

Due to the wet weather, Phase 2 of the 11st project is scheduled to start now around July 30. Hanks Excavating is expecting a timeline of the construction phase to be completed within 45 working days, weather permitting.

The team has oiled the following roads. Janet, Kenn, Dennis, Long, 11st, Mine Haul, Freedom, Justus, Harmony, Independence, Meadow, Friendship, S28.

Yellow No Outlet signs will be placed on top of street signs in high volume areas. This was a request from EMS services to assist First Responders with navigating the best a quickest route through neighborhoods. The older large outdated and or dead-end signs on these streets will be removed.

Crew has been responding to calls for removal of a tree, limbs and dead animals in the roadway and have been out trimming back trees, collecting and or removing dead brush and clearing drains from blockage from the continuing heavy storms. The street sweeper continues to be out removing leaves and small road debris and we are mowing the grass on our right of ways. Small concrete, asphalt road patch work is ongoing.
