Supervisor Barnes stated that a cable boring company hit our trunk line on 158 and 15. We were able to repair it the next day and were reimbursed by the company that hit it. Mr. Barnes said there is a church group out of California that is going to build a subdivision of 25 to 30 retirement homes, a gymnasium and a church on Hartman Ln. He said we are putting in the sewer lines and tapping into the sewer. He said it is St. Clair Township, but the sewage goes to Swansea. He also said we received the park grant for \$134,000.00 that we applied for. He said that we have not heard anything on the new sewer tanks. Everything has been submitted, so we are just waiting. Lastly, we had a motor on a pump go out at the sewer plant but it has been repaired.

## **PARK BOARD REPORT**

Don Wallace said that the Park Board did meet and that the cleanup day scheduled for Oct 3, 2020 in Centennial Park is postponed due to Covid. They have been discussing what will need to be worked on in Centennial Park as far as the trails. They talked about erosions issues in the creek and making sure walking trails are safe.

Road Commissioners Report 9/22/2020

Covid-19 precautions: The crew is working normal hours and until further notice the following will apply to each Road District Township Vehicle. They will be restricted to one team member with no passengers allowed unless approved by me. All team members and vehicles will have hand sanitizers, wipes, gloves, and face masks made available. Road District Team Members have given a contactless door opening and touch screen tool. The road crew break room has been separated into 2 sections with part of the crew in the outer conference room and normal rest area during lunch and breaks.

The crew has been responding to calls for clearing drains from blockage, removal of trash and other discarded items, dead animals, tree limbs, trimming trees, collecting and or removing of dead brush.

The street sweeper continues to be out removing leaves and small road debris.

We are mowing the grass on our right of ways and doing small concrete and asphalt patch work.
