## **ROAD COMMISSIONER'S REPORT**

Road Commissioner Trentman said that his crew has been mowing and fixing potholes. He has put up safety lights on B Street Rd from the railroad tracks towards West Blvd. They are also going to restripe B Street Rd from West Blvd to the tracks. He has been moving the radar trailer around and has now been on St. Johns and Old Collinsville Rd. He said they have started trimming branches that are hanging down on off Hwy. 158 and are going to work their way all through the township. ## **SUPERVISOR'S REPORT**

Supervisor Korves said they had the cleanup day at Centennial Park on Oct. 16. She said there was a good turnout of people to help and they got a decent amount done. She also said there will be changes in the park due to an incident. The Swansea police will be locking the bathroom at dusk and the street department will unlock it at 7am. We have a sewer worker out with a non-work related injury for about 4 to 6 months. We do have a part time worker 3 days a week so we can keep up with the parks and don't get behind on sewer work.

- A. Information - Centennial Park playground equipment has been ordered and has a ship date of Feb. 2022.
- B. Bank of Belleville – We have already started making our transition and it's been going smoothly.
- C. Locker room update – we had a few issues from the drawings to the building. Supervisor Korves met with Calhoun and made a few adaptations.

- D. Centennial sign for entrance and path signs – The Centennial sign has been picked up and will hopefully be put up in a week or two. The path signs are in and will probably put them in early spring.
- E. Creek Bank – Supervisor Korves said the permit has been mailed but we haven't received it.
- F. Loop Creek , Phase II - Supervisor Korves met with KRB and its coming along good. We are hoping for an end of November finish.
