## **ROAD COMMISSIONER'S REPORT**

Road Commissioner Trentman said that they finally solved 2 water issues that were brought up last meeting, one on St. John's and one on Country Meadows. He is applying for a Surface Transportation Program Grant for the remainder of So. 11<sup>th</sup> St. that goes out to Rt. 15. He is also getting ready to bid 11<sup>th</sup> St. connector between Phase 1 and 3 and the state and county are looking at the plans. The crew is starting to trim trees again that are hanging over roads. Mr. Trentman said they have a lot of projects going on right now, so you can contact him with any questions at the township.

Supervisor Korves said Calhoun's first payment has been paid for the locker room project and it is moving along well. She also let the trustees know that the Park Board minutes from the January 11<sup>th</sup> were available.
