- A. Trustee Buechler made a motion to accept the Regular Board Meeting minutes for February 22, 2022 as presented. Trustee Miller seconded the motion. Voice vote. All in favor.

Trustee Greenfield made a motion to approve the Treasurer's Report as presented for the month of February, 2022. Trustee Buechler seconded the motion. Voice vote. All in favor.

### BUDGET REPORT

Trustee Miller made a motion to approve the Budget Report as presented for the month February, 2022. Trustee Buechler seconded the motion. Voice vote. All in favor.

## **ROAD COMMISSIONER'S REPORT**

They had an outstanding bill that we reviewed and agreed to the owner's son paying half of the bill. Trustee Miller made a motion to approve. Trustee Greenfield seconded the motion. Voice vote. All in favor.
- B. KDG Engineering agreement for MEPRD grant 2022 – discussed and voted. Supervisor Korves said she would like to put up a gazebo, a pavilion, revive the trail around the pond and also put a fountain in the pond to get the water moving. Trustee Miller made a motion to approve with changes in the contract. Trustee Buechler seconded it. Voice vote. All in favor.
- C. New maps for Centennial Park information sign – discussed and voted. Trustee Buechler made a motion to approve. Trustee Miller seconded it. Voice vote. All in favor.
