- A. St. Clair County MTAD township map discussed and voted. Jennifer Gomric, St. Clair County Assessor, sent a letter explaining that every ten years her office is mandated to present maps to all local townships for suggested multi-township assessment districts for purpose of assessment. The proposed MTADs are the same as the ones currently in place. Trustee Buechler made a motion to accept the proposed map. Trustee Miller seconded the motion. Voice vote. All in favor.
- B. Ord#2022-T2, to allow voters in St. Clair Township option of electric aggregate discussed and voted. Steve Bryant of Good Energy explained the electric supply choice. Our board must pass an ordinance allowing it to go on the ballot in November. The residents in the unincorporated area vote whether to be part of the aggregation. This is an opt-out program but will be explained on electric supply choice for lower monthly charges. Trustee Greenfield made a motion to accept. Trustee Miller seconded the motion. Roll call vote. All in favor.

C. Update on WWTP expansion. Supervisor Korves will meet with Volkert to keep updated on the sewer expansion.
