## **ROAD COMMISSIONER'S REPORT**

Road Commissioner Trentman has a lot of projects going on. Some of the things he listed are; 1) working on some new grant opportunities. 2) Put Beacon lights on B St. Rd. curve. Waiting on road restriping. 3) Shoveled storm drains out in Richland Prairie, going to vac out the pipes because the ditch fills in and water has nowhere to go. 4) Water issues in backyards of Weatherstone again, nowhere for water to drain. 5) Going to buy a concrete planer to lower high spots in gutters on roads. 6) Finished up work on Storm Water Drop Box in Villa Madero. 7) cold patching roads for July 12<sup>th</sup> and 14<sup>th</sup> oil date. 8) Finish up concrete work on Clinton Hill Dr., Cresthaven, Ellington Meadows. 9) curb replacement on Diane Dr. and Coral Dr. You can contact him with any questions at the township.

- C. Trash cans for Centennial Park – discussed and voted. We would like to get 8 of the cans. They would be on a pedestal to make them more secure. Trustee Greenfield made a motion to approve. Trustee Buechler seconded the motion. Voice vote. All in favor.
- D. Resolution 2022-1 for MEPRD Grant 2023 – discussed and voted. This would be for a pavilion, gazebo and fountain in Centennial Park. . Trustee Buechler made a motion to approve. Trustee Greenfield seconded the motion. Voice vote. All in favor.
- E. Sewer repair on Winthrop – discussed and voted. It was a major backup so Supervisor Korves filed an insurance claim. Our deductible is \$5000. Trustee Greenfield made a motion to approve the payment of the deductible of \$5000. Trustee Buechler seconded the motion. Voice vote. All in favor.

- F. Creek bank stabilization – Hanks – discussed and voted. Approve the repair of 70ft by 20ft area along the creek bank at Centennial Park under the first bridge on the west side. Total cost for labor, equipment and material is \$19,795.
