They will be installing a new curb with a storm sewer underneath and the pavement is deteriorating due to water accumulation. 2) They are getting set up for sucking up leaves and he ordered a new leaf box. 3) He is working on a grant through the State of Illinois for a new leaf machine. 5) Cleaning drains. 6) Working on Park Rd. at the substation. When work was being conducted, the shoulders were damaged. 7) Mr. Trentman is lowering the speed limit on Whiteside Dr. from 30 to 25. 8) In the Woodfield subdivision a broadband company wants to come through. He is working on getting a permit with our attorney. 9) Culvert work. 10) He has also moved the radar trailer and one of the mounted speed sign around.
